Admission and continued enrollment in the Gainesville City School System is based on the following:

- (1) Above average grades and standardized test scores, (2) History of good behavior, (3) Good attendance (fewer than 6 unexcused absences and tardies per year), (4) Timely payment of tuition fees due on or before scheduled payment dates that are listed above. Failure to remit payment will result in withdrawal of student. (5) Parent maintains a cooperative partnership with the school and district.
- (6) Student can be accommodated by current instructional program services that will meet the educational, physical, and emotional needs of the student within the district's capacity. (7) Gainesville City School System must be able to accommodate the applicant without placing undue financial burden on the school system. (8) The student must provide Gainesville City School System the following documents in acceptable form before enrollment can be considered: a) The transcript (report card and standardized test scores) from the student's former school, b) Discipline records from the student's former school as required by the laws of the State of Georgia, c) Attendance records from student's former school.
- (9) Students are subject to suspension, dismissal, or expulsion and this Enrollment Contract may be revoked and the student dismissed or expelled in accordance with any and all Gainesville City School System policies or regulations. **(Policy JBCB)**
